The lay-led Remembrance Day Service on Nov. 10th received lots of positive feedback. The Worship Committee is grateful for Rev. Anita's leadership and organization of this service before her leave began. The Committee discussed that some people would like this service to have a more modern focus-current conflicts and victims both military and civilian. Many UCC churches have a Peace Sunday following Remembrance Day which includes these elements. All food for thought moving forward.

The Committee is working to support Rev. Anita in creating an Advent and Christmas Worship Series. Rev. Anita can provide information about the content of this series. Organizational pieces to note are:

- Arlene Robinson and our many musicians are creating an Advent/Christmas choir. Rehearsals begin Saturday, Nov. 23 at 2:30 p.m.
- Dec. 1- Is the first Sunday in Advent. We will encourage people to bring their toys for Community Christmas Cares on this Sunday. Toys can be accepted until Dec. 8. Squamish United Church has been asked to focus on toys for infants (birth-18 months).
- Dec. 8- Rev. Anita and Rev. Cameron are planning a joint worship to take place at St. John the Divine at 10 a.m. This is an opportunity to join together with both ministers presiding and shared music and children's elements. All are encouraged after coffee at St. John's to gather at Squamish United for a pancake lunch provided by the Scouts.
- Dec. 29th- will be a lay-led service of carols and hymn led by our musicians under the guidance of Arlene Robinson and Carol Grolman.

M&P Report for the Board

We are happy to announce that beginning this weekend Squamish United Church will have a new cleaner, Alisha Matthews.

Jason, our previous cleaner, was informed that his services are no longer needed. Julie Larson met with him Tuesday, Nov.19 to collect his fob and final invoice and to assist him in gathering personal cleaning materials that he was storing at the church. In addition, to his final invoice we have agreed to pay him for two additional weeks as severance pay. Grace has the invoice.

Alisha Matthews comes well recommended. M+P thanks Cindy Roy and Sarena Jonah for participating in interviewing Alisha. Alisha often travels by bicycle and therefore we have agreed to provide cleaning supplies. At this time, a new dust mop and new wet mop have been donated. The vacuum cleaner situation is ongoing but on the way to being solved. Many of our consumable supplies have been donated. Alisha will be responsible for washing cleaning cloths and mops so that we can rely less on single use products. Estimated additional costs to the church for supplies should be less than \$30 per month. Having our own supplies also allows us and renters to do a better job of cleaning up after activities. Most often Alisha will clean very early on Sunday mornings. She knows that cleaning must be completed, and floors dry by 9 a.m. She will also do mid-week and special event cleanings as needed and directed by Sarena.

Finance Committee

1. I have included an excel worksheet that you can use to start 2025 planning. In the column for 2025 I have put in the summation equations where they belong.

2. Some thoughts:

I think that congregational giving will come in just about on budget. However, that includes the \$5000 unexpected donation. This is an increase of about 9% from last year, exceeding inflation.

Facility donations will underperform by about 10%

Fund raising estimates are difficult because of our age-old problem of double counting between UCW and non-UCW events.

Of course the expense for the blinds was a big hit. I was not here when that happened, but that is an example of what targeted donations could have been used for. Targeted donations is the category for saying something happened outside of our budget and we need to collect donations for this specific use. I believe in the old adage, "don't waste a good crisis".

Worship came in quite a bit over budget, their expenses are essential, so it is just a matter of getting a better estimate for next year

The board did a great job to reduce insurance expenses.
